

# Instruction for Contributions to Journal of Advanced Science (JAS)

19 July, 2000

## 1. Scope

Society of Advanced Science (SAS) publishes The Journal of Advanced Science (JAS) which covers science and technology in the field of natural science such as mathematics, physics, chemistry, biology, physical geography, electronics, information engineering, mechanics, material science, and medical science.

Contribution on other fields of science and technology will be accepted when JAS Editorial board admits.

## 2. Classification of Manuscripts

Contributed articles are classified into "Paper", "Letter", "Technical report" and "Proceedings" as original submissions and others such as "Review", "Exposition", "Preface", "Essay", "Lecture", "Report", "Talk" and "Patent". All these submissions should not be published elsewhere. "Product Information" and "Advertisement" can be also contributed. Manuscripts are accepted in English or Japanese.

## 3. Contents of Each Article

Nominal content of each article is as follows.

### 3-1.

"Paper" must include new fundamental or practical results described originally within the scope of this journal, which neither has being published nor is being submitted for publication elsewhere. It will be refereed.

### 3-2.

"Letter" is announcing significant new results or proposing new ideas within the classification of 3-1 as quickly as possible. It may be concluded without enough discussion. It will be refereed.

### 3-3.

"Technical report" should describe content other than 3-1, like experimental progress

in development, new useful technologies, improvements and analyses of test processes or productions. It will be refereed.

### 3-4.

"Proceedings" is the article submitted to the symposium basically organized by SAS. It will be refereed by the committee for publication of Proceedings at the Symposium.

### 3-5.

"Review" should provide a comprehensive survey and/or outlook on newly developing fields and important topics. A review must not only describe results from other papers but must contain an original viewpoints by the author. It will be refereed.

### 3-6.

"Exposition" should explains specific topics on science and technology understandably for all readers.

### 3-7.

"Preface" should enlighten and proceed science and technology.

### 3-8.

"Essay" describes opinions or thoughts concerning to advances science and technology.

### 3-9.

"Lecture" should deal new science and technology and introduce to other scientific and technical readers in several sequences of journal issues.

### 3-10.

"Report" should describe contents and summary of conference, symposium, or invited talks on science and technology.

### 3-11.

"Talk" is a place to exchange readers comments and opinions.

### 3-12.

"patent" should describe content of patent newly developed.

### **3-13.**

“Product Information” is to introduce the specification of the product from the subsidizing company.

### **3-14.**

“Advertisement” is to advertise the products of the subsidized company, group and related company.

## **4. Manuscript Format**

Manuscript should be prepared as follows.

### **4-1.**

The length of submitting manuscript is denoted in “Further Instruction”. Manuscripts with extended pages are also allowed when Editorial Board admits.

### **4-2.**

Manuscript should be prepared in accordance with “INSTRUCTION FOR THE PREPARATION AND TYPING OF CAMERA READY CONTRIBUTION”.

### **4-3.**

Manuscript should be submitted to the Editor-in-Chief of the Journal of Advanced Science (JAS). The original and one duplicate of the entire manuscript are required.

## **5. Publication**

Editorial Board requests suitably selected referees their comments on the contributed manuscript, afterwards the Board decides whether or not to accept the manuscript for publication. Authors receive a notification of acceptance or rejection of their manuscript, or a request for revision. Authors whose manuscript is rejected may claim the criticism of the referee against the Editorial Board, if they wish.

Manuscript returned to authors for revision should be resubmitted within 6 months for Paper, Letter, Technical Report, Review and Exposition. The revision for the manuscript of Proceedings is requested by the committee of the Symposium. Manuscripts not returned within above

mentioned period will be regarded to be withdrawn.

## **6. Publication Charge**

Contributor is requested to pay the publication charge. The charging amount is denoted in “Further Instruction”. “Product Information” and “Advertisement” charges are requested other fee.

## **7. Copyright**

Copyright for the articles submitted to this journal is transferred to the Publication Board, Journal of Advanced Science (JAS), when the article is published in the journal.

### **7-1.**

Anyone who wishes to reproduce, translate or use in another publication, all or any part of a contribution published in the Journal of Advanced Science (JAS) must obtain an agreement of the Publication Board of JAS and must clearly state with a citation that it was published in the Journal of Advanced Science (JAS).

## **8. Reprints**

Reprints can be ordered. Precise regulation is denoted in “Further Instruction”.

## **<Further Instruction>**

### **1. Length of Manuscript**

The length of manuscript is limited as follows.

#### **1-1.**

“Paper” and “Technical Report” should be written within 8 pages.

#### **1-2.**

“Letter” should be written in 2 to 4 pages.

#### **1-3.**

“Review”, “Exposition”, “Essay”, “Lecture”, “Report” should be written in 1 to 4 pages.

#### **1-4.**

“Preface” should be written within 1 page.

**1-5.**

“Advertisement” should not exceed a half page.

**1-6.**

“Proceedings” should be written following to the instruction defined by the committee for publication of proceedings.

**2. Publication Charge**

Publication of the article in 3-1, 3-2, 3-3 and 3-4. is free for the member or the attendee pay a charge for the symposium.
